Actions from Previous Meeting

Previous Action	Comment
Finalised drawings to be sent to Stakeholder Engagement Group and all groups involved in the Pansy Walk details	Drawing WoL-MF-SA-001 T1 shows the footpath closures the details of which have to be agreed with CEC through the TTRO process. The section of footpath from the Baird Drive bridge to the Ice Rink Pedestrian bridge on the right bank of the WoL will not be available for pedestrians and passage over this section will be via the public footpaths along Baird Drive, Riversdale Road and Riversdale Crescent. Footpath access through Roseburn Park will be maintained.
JWN to meet with school to discuss working hours and construction traffic	The schools have been apprised of the information shown on drawing WoL-MF-SA-001 T1, in particular of roads where no construction access will be allowed. Site working hours are between 07.00 and 19.00 on weekdays and 08.00 to 13.00 on Saturdays

Another discussion with Scottish Water to be held in regards to the removal of the pumping station at the north east of the park	Scottish Water are not involved in the provision of the pumping station and CEC will become the asset owner. The intent is to review the requirements for the pumping station with the selected Contractor
A briefing note on the pumping station and the area that is required to be used to be sent to Stakeholder Engagement Group	A presentation was given to the Corstorphine Community Council on 23 June 2015 of the area required along with the proposed rehabilitation measures.
JWN to discuss directly with DAFS Cricket Club and the Primary School in regards to the cricket pitch and football practice field	Discussions have been held. Refer to Drawing WoL-MF-SA-001 T1 attached which shows the lands available for the mentioned facilities



Gas Main Diversion




Programme for diversion
